WHEREAS, in 1984 the City changed this designation and identified itself as the local partner; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to apply to the California Arts Council State/Local Partnership Program for a grant in the amount of \$40,000 for the Fiscal Year 2001 Arts and Cultural Program, to support programs and services of the Commission for Arts and Culture.

BE IT FURTHER RESOLVED, that the City Manager or his designee is hereby authorized to administer any grant funds received from the California Arts Council State/Local Partnership Program for Fiscal Year 2001, for program and administrative support of the City's Arts and Culture Program and the Neighborhood Arts Program.

BE IT FURTHER RESOLVED, that the one-to one match funding required by the California Arts Council S/LPP funding will be provided through the Arts and Culture Program's Grant Matching Fund reserve.
