ADOPTED ON APR 17 2000

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the West Linda Vista Trunk Sewer, Phase II, filed in the office of the City Clerk of The City of San Diego, California, on APR 17 2000, and bearing official Document No. 174951 be and the same are hereby approved.

2. That the Contract Services Division of The City of San Diego is authorized and directed to proceed to publish in accordance with law, notice to ~~contractors~~ calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to establish contract phases and to execute a contract with the lowest responsible bidder for the West Linda Vista Trunk Sewer, Phase II.


4. That the City Auditor and Comptroller is hereby authorized to transfer \$1,056,301 from Sewer Fund 41506, CIP No. 45-936.0, Sewer System Canyon Access to Sewer Fund 41506, CIP No. 46-199.0, West Linda Vista Trunk Sewer, for the construction of Phase II.

5. That the expenditure, not to exceed \$1,190,400 from Sewer Fund 41506, CIP No. 46-199.0, West Linda Vista Trunk Sewer, for the construction of Phase II, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs.

6. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
