

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1:

- 1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the Sewer and Water Group 663, filed in the office of the City Clerk of The City of San Diego, California, on MAY 0 1 2000, and bearing official Document No. W.D 173691 be and the same are hereby approved.
- 2. That the Contract Services Division of The City of San Diego is authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to establish contract funding phases and execute a construction contract with the lowest responsible and reliable bidder for Sewer and Water Group 663.
- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$479,548 from Water Fund 41500, CIP 72-920.0, Black Mountain Water Treatment Plant, to Water Fund 41500, CIP 73-083.0, Annual Allocation Water Main Replacement, for the construction of Sewer and Water Group 663.

- 5. That the appropriation and expenditure of an amount not to exceed \$2,939,342 from Sewer Fund 41506, CIP 44-001.0, Annual Allocation Sewer Main Replacements, and \$514,548 from Water Fund 41500, CIP 73-083.0, Annual Allocation Water Main Replacements, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs.
- 6. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
