- 4. That the City Auditor and Comptroller is hereby authorized to accept the amount of \$1,000,000 from the San Diego Unified Port District, solely and exclusively to provide funds for the Convention Center Dewatering Outfall, and to deposit said amount into Convention Center Expansion Fund No. 102212, solely and exclusively for use of the Convention Center Dewatering Outfall, CIP 12-147.0.

- 5. That the appropriation of an amount not to exceed \$2,000,000 from the Convention Center Expansion Fund No. 102212 is hereby authorized, solely and exclusively to provide funds for CIP 12-147.0, Convention Center Dewatering Outfall, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.
- 6. That the expenditure of an amount not to exceed \$1,100,000 from Convention Center Expansion Fund No. 102212, CIP 12-147.0, Convention Center Dewatering Outfall, is hereby authorized, solely and exclusively to provide funds for this project and contingencies.
- 7. That the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
