WHEREAS, The City of San Diego, San Diego Police Department requires blood drawing, breath alcohol test services, buccal swabs and collection of prints; and

WHEREAS, these services must be performed in compliance with California Code of Regulations, Title 17, as it relates to blood draws; and

WHEREAS, qualified personnel are defined as those who meet the requirements for forensic alcohol blood drawing as outlined in California Vehicle Code section 23158; and

WHEREAS, those individuals conducting the services must be available to testify in the County of San Diego; and

WHEREAS, American Forensic Nurses in Palm Springs, California, has provided, and is able to handle the routine volume of services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized to negotiate and execute a contract, a copy of which is on file with the City Clerk as Document No. RR- 293063, with American Forensic Nurses for blood drawing, breath alcohol services, buccal swab and collection of prints for a one-year period from February 1, 2000 to February 1, 2001, with options to renew for four additional one-year periods, to expend approximately \$200,000 annually, subject to appropriations.

BE IT FURTHER RESOLVED, that the City Clerk is directed to enter the date of the passage of this Resolution in Section 8.1 and the date "April 25, 2000" in Section 23 of this Agreement.
