## ADOPTED ON **MAY 1 5 2000**

WHEREAS, by Resolution No. 290988, adopted November 24, 1998, and Resolution No. 291565, adopted May 4, 1999, the Council for The City of San Diego authorized the filing of eminent domain proceedings to acquire property rights necessary for the project known as the South Bay Reclamation Sewer and Pump Station - Package A; and

WHEREAS, after unsuccessful attempts to negotiate the purchase of the property interests required for the project, an eminent domain action entitled *The City of San Diego v.*McClurken Machinery, Inc., San Diego County Superior Court Case No. 727522, was filed; and

WHEREAS, after a jury trial, a judgment was entered in the eminent domain action for an amount in excess of those funds originally authorized for the project; and

WHEREAS, as part of the judgment, the City is faced with further potential costs if the Court awards the payment of attorneys' fees and litigation expenses to the property owner; and

WHEREAS, the City has also incurred costs in prosecuting the eminent domain action for experts, litigation expenses, labor and other miscellaneous items; and

WHEREAS, the amount of additional funds required to pay the jury award and all other costs and fees is estimated not to exceed \$915,000.00; and

WHEREAS, the required funds are available from Sewer Fund 41509, CIP 40-911.1 South Bay Pump Station and Conveyance System - Phase 1 and would need to be transferred to Sewer Fund 41509, CIP 40-911.3 South Bay Reclamation Sewer and Pump Station - Package A to effect payment; NOW THEREFORE,

BE IT RESOLVED, that the City Auditor and Comptroller is authorized to transfer the sum of \$915,000.00, from Sewer Fund 41509, CIP 40-911.1 South Bay Pump Station and Conveyance System - Phase 1 to Sewer Fund 41509, CIP 40-911.3 South Bay Reclamation Sewer and Pump Station - Package A.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$915,000.00, from Sewer Fund 41509, CIP 40-911.3 South Bay Reclamation Sewer and Pump Station - Package A, to satisfy the judgment in San Diego County Superior Court Case No. 727522, entitled *The City of San Diego v. McClurken Machinery, Inc.*, and to fund any attorneys' fees and litigation expenses that may be awarded by the Court to the property owner or incurred by the City.
