- 4. That the expenditure of an amount not to exceed \$150,000 from CIP 32-0100 (Annual Allocation Unclassified Disposal Site Closure), Refuse Disposal Enterprise Fund, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
