
BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby accepts and appropriates \$240,000 of Surface Transportation Program Funds (Fund No. 38970) for the design and construction of TS/SL at Activity Road/Black Mountain Road and Camino del Norte/Paseo Montanoso.

BE IT FURTHER RESOLVED, that the addition of CIP 62-206.0, "TS/SL at Activity Road/Black Mountain Road and Camino del Norte/Paseo Montanoso" to the FY 2000 Capital Improvements Program, in the amount of \$240,000, is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$240,000, (Fund No. 38970) for the purpose of funding the design and construction of "TS/SL at Activity Road/Black Mountain Road and Camino del Norte/Paseo Montanoso", contingent upon receipt of fully executed program supplements, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserves.
