## RESOLUTION NUMBER R- 293245 ADOPTED ON JUN 5 - 2000

WHEREAS, each year during the fourth quarter, it is necessary to make, and a request is made, to transfer funds between and within City departments and funds to avoid projected deficits; and

WHEREAS, such deficits occur for many reasons, most of which relate to work load requirements or unanticipated expenditures for supplies and services; and

WHEREAS, it is recommended therein that the City Manager's calculations, transfers and carryovers be approved; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to:

- 1. Increase General Fund appropriations up to the amount of \$4.6 million, to be funded from Motor Vehicle License Fees received in excess of the budgeted amount, for the Environmental Services and Fire and Life Safety departments, which are projected to exceed their budgeted appropriations, and the Police department, which is projected to exceed its non-personnel allotment.
- 2. Transfer General Fund monies between departments to offset projected department deficits and to the Allocated Reserve to fund projects that will not be completed in the current fiscal year.
- 3. Transfer monies within and between funds, increase budgets, add projects, and authorize expenditures for the purposes specified in City Manager Report No. 00-106.

- 4. Increase the General Fund appropriations from revenues received in excess of estimates for certain departments projected to exceed their budgeted appropriation.
- 5. Make any additional appropriation adjustments and fund transfers that may be necessary to reconcile revenues to expenditures and to maintain appropriate reserve balances.
- 6. Upon direction from the Financial Management Director, to appropriate and expend unanticipated revenues specifically restricted for use on specific projects within the approved Capital Improvements Program.
