WHEREAS, each year the San Diego Police Department sponsors the School Safety Patrol Summer Camp; and

WHEREAS, this camp is held at the Palomar County School Camp; and WHEREAS, the School Safety Patrol Summer Camp affords fifth and sixth grade students an educational growth and recreational experience; and

WHEREAS, the San Diego Unified School District has agreed to provide transportation for students to and from the camp; and

WHEREAS, the transportation to be provided will consist of up to five (5) sixty (60) passenger buses to depart from San Diego Qualcomm Stadium at 8:30 a.m., on July 18, July 24, July 31 and August 7, 2000; departing from Camp Palomar at 12:30 p.m. on July 21, July 27, August 3 and August 10, 2000; and

WHEREAS, the agreement by the San Diego Unified School District to provide transportation is conditional on the specified terms; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the City of San Diego will assume total responsibility for the conduct of students while riding the bus, including but not limited to vandalism to school equipment and liability for damages resulting from objects thrown from the bus;
- 2. That the City of San Diego will bear an equal share of the liability over and above insurance limitations if the school district meets the following performance

standards: All drivers are licensed in accordance with the California Vehicle Code for transporting school students; all buses are Class "A" rated, meeting all safety regulations prescribed in the California Vehicle Code and the California Education Code; and that the school district's insurance policy remains in effect;

3. That the City Manager is authorized and empowered to enter into a letter of agreement with the San Diego Unified School District reflecting the terms of this resolution. This letter agreement is on file in the Office of the City Clerk as Document No. RR-293390;

BE IT FURTHER RESOLVED, that the expenditure of approximately one hundred and fifteen thousand dollars (\$115,000) from Police Department budgeted funds (Fund 100, Department 110, Organization 4005, Job Order 005535, Object Account 4279) is hereby authorized solely and exclusively for the purpose of providing funds for the School Safety Patrol Camp.
