BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Orrick, Herrington & Sutcliffe, in an amount not to exceed \$35,000 for ballpark disclosure counsel services contingent upon the issuance of bond financing, and in an amount not to exceed \$473,500 for Ballpark other bond financing disclosure counsel services and litigation review services, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 293412.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$473,500 from Facilities Ballpark Fund 102214, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
