BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- That the Community Development Block Grant [CDBG] Program Year 1999
 budget is amended to transfer \$121,200 from Section 108 payments, Mercado del Barrio to
 Barrio Logan Redevelopment Project Area, Planning and Administration.
- 2. That the City Auditor and Comptroller is authorized and directed to transfer \$121,200 to the Redevelopment Agency of The City of San Diego [the Agency] as an interest bearing loan to cover Planning and Administration costs for the Barrio Logan Project Area.
- 3. That the City Auditor and Comptroller is authorized and directed to transfer \$50,000 in CDBG funds allocated to the Agency as an interest bearing loan to cover Planning and Administration costs for the Barrio Logan Expansion Project.
- 4. That the City Auditor and Comptroller is directed to record the above disbursement to the Agency as a loan which shall accrue interest at the rate approved by The City of San Diego Council Resolution No. R-282415 on July 27, 1993; such interest accrual to be calculated by the City Auditor and Comptroller.
- 5. That in the event that the Agency issues bonds, notes, refunding bonds or other instruments of indebtedness of the Agency to carry out the Barrio Logan Redevelopment Project, then any indebtedness of the Agency to the City, including any interest accrued thereon, shall be

deemed not to be a first pledge of tax increment allocation received by the Agency pursuant to California Health and Safety Code section 33670; and any indebtedness of the Agency to the City, including any interest accrued thereon shall be subordinate to any pledge of tax increments to bondholders or the holders of other such instruments of indebtedness.
