WHEREAS, the Water Department has recently conducted an in-depth analysis regarding the fees that it charges for services related to water billing and collection, and the fees that it charges related to the fire hydrant meter program; and

WHEREAS, as a result of that analysis, the Water Department has determined that some of the fees associated with water billing and collection and the fire hydrant meter program do not cover the cost of providing the service, and should be increased; and

WHEREAS, as a further result of that analysis, which included industry bench marking, the Water Department has determined that it should be charging a fee for some services associated with water billing and collection and the fire hydrant meter program, which do not currently involve a fee; and

WHEREAS, the new and increased fees described above will ensure that the listed services are paid for by the customer receiving the service, not other ratepayers; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, to authorize the changes to the Water Department Fees and Charges Schedule for Billing and Collections, which is on file in the Office of the City Clerk as Document No. <u>Res 293483-1</u>.

BE IT FURTHER RESOLVED, that the changes to the Water Department Fees and Charges Schedule for the Fire Hydrant Meter Program, which is on file in the Office of the City Clerk as Document No. RR-#293483; are authorized.
