BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of said City, an agreement with Boyle Engineering Corporation to provide design services for water quality improvements at San Vicente, El Capitan and Lower Otay Reservoirs, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 293547.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$533,230 from Water Revenue Fund 41500, CIP No. 73-291.0, Reservoir Water Quality Systems, for the purpose of funding this agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
