
RESOLUTION NUMBER R-293555

ADOPTED ON JUL 24 2000

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 2 to the Agreement with Hirsch & Company, for closed circuit television inspection and evaluation of small diameter sewer mains on an as-needed basis at a cost not to exceed \$400,000 and project management cost of \$50,000, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-293555. Execution of Amendment No. 2 by the City Manager is contingent upon City Council approval of the Metropolitan Wastewater Department's Fiscal Year (FY) 2001 Operating Budget.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$450,000 from Sewer Fund 41506, FY 2001 Appropriation, contingent upon the approval of the FY 2001 Operating budget, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
