

RESOLUTION NUMBER R-293796

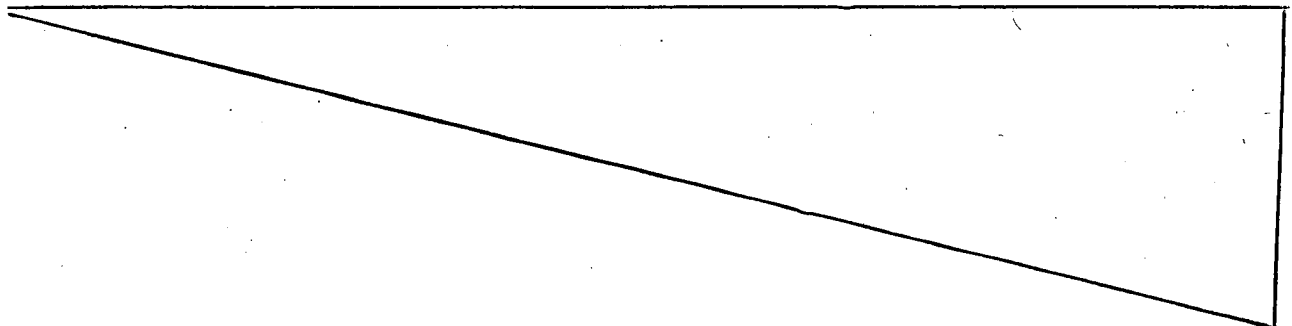
ADOPTED ON SEPTEMBER 12, 2000

BE IT RESOLVED, by the Council of the City of San Diego, that the list of proposed projects for \$9.1 million TransNet Funding (AB 2928) included in the memorandum dated July 19, 2000 to Chairman Byron Wear and Honorable Members of the Land Use and Housing Committee from Councilmembers Christine Kehoe and George Stevens (Attachment A) is hereby approved.

BE IT FURTHER RESOLVED, that the \$1 million allotted for sidewalks is to be expended according to the following breakdown: \$300,000 to the 50/50 program; \$200,000 for the Americans with Disabilities (ADA) ramp backlog; and \$500,000 for sidewalk repair.

BE IT FURTHER RESOLVED, that the \$300,000 being transferred from the 8th Avenue Storm Drain Project be allocated for the two traffic lights in Council District 4.

BE IT FURTHER RESOLVED, that in Council District 3, change the traffic signal that was incorrectly identified at the 28th Street and Redwood to reconfigure the area to add stop signs at 28th and Redwood at Pershing.



BE IT FURTHER RESOLVED, that from the \$250,000 allocation for Citywide Street
Trees/Trimming a one-time allocation should be made for watering the trees that the City plants
to allow the establishment of the trees.
