WHEREAS, concurrently with this action, the City will sell a 5.70 acre parcel to the Del Mar Union School District for \$1,547,702.89 for the Neighborhood 10 school; and

WHEREAS, these funds will be applied to the purchase price of the property to be acquired from Pardee by the City, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$3,784,948.33 from CIP No. 29-687.0, FBA Fund 79008, for the acquisition of property rights, title, escrow, labor, Subdivision Map Act reimbursements, and miscellaneous costs in connection with the purchase of the 13.33-acre parcel for the Carmel Valley Neighborhood 10 School/Park Site Project.

BE IT FURTHER RESOLVED, as additional consideration for the purchase of the 13.33 acres, that the City Manager, or designee, is authorized and empowered to execute, for and on behalf of the City, a grant deed to Pardee Construction Company for the conveyance of an uneconomic remnant, a 479 square foot City-owned parcel, as more particularly described in the grant deed. A copy of the grant deed is on file in the office of the City Clerk as Document No. RR- 293811-1.

BE IT FURTHER RESOLVED, that the City Manager, or designee, is authorized and empowered to execute, for and on behalf of the City, a grant deed to the Del Mar Union School District for the sale of 5.70 acres of City-owned property for \$1,547,702.89, and an easement for a sewer facility for the Neighborhood 10 school, as more particularly described in the grant deed.
