BE IT FURTHER RESOLVED, that the Council accepts on behalf o the City of San Diego any and all abutters rights of access in and to Avenida De Las Vistas adjacent and contiguous to Lots 285 through 293 inclusive, Lots 338 through 342 inclusive, Lots 343 through 357 inclusive, and Lot 401 and Lot "G," all as shown on this MAP within this subdivision. The City Engineer is authorized to revest all or part of said access rights if there is a change in circumstances making access necessary and safe.

BE IT FURTHER RESOLVED, that the Clerk of the City is authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP

and that the street(s) and portion(s) of street(s) are accepted on behalf of the public as stated in this resolution.
