- 4. That the City Auditor and Comptroller is authorized to increase the FY2001 Capital Improvement Program budget by \$15,357,549 in CIP No. 73-338.0 Water Department Central Operations Facility, Water Fund No. 41500 from the Water Department unappropriated fund balance.

5. That the expenditure, not to exceed \$60,717,763 from CIP No. 73-338.0 Water Department Central Operations Facility, Water Fund No. 41500 and \$2,280,000 from CIP No. 73-331.0, Annual Allocation for Pooled Contingency, Water Fund No. 41500, for the Construction of the Water Department Central Operations Facility Phase A and Phase B is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, provided that the City Auditor and Comptroller first furnishes a certificate demonstrating that the funds necessary for such expenditure are or will be on deposit in the City Treasury.

6. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

7. That the final EIR No. 88-0210, EIR Addendum No. 92-0301, and EIR Addendum No. 96-7585, have been reviewed and considered prior to approving the project.
