

RESOLUTION NUMBER R- 293977

ADOPTED ON OCT 16 2000

A RESOLUTION CALLING FOR A PUBLIC HEARING TO DETERMINE WHETHER THE PUBLIC HEALTH, SAFETY, OR GENERAL WELFARE REQUIRES THE FORMATION OF UNDERGROUND UTILITY DISTRICTS AS FOLLOWS: B STREET (FROM 19TH TO 30TH STREETS); 25TH STREET (FROM MARKET TO COMMERCIAL STREETS); SATURN BOULEVARD (FROM CORONADO TO LEON AVENUES); SCOTT STREET (900 BLOCK); SILVERADO STREET (FROM EADS TO IVANHOE AVENUES); AND CCDC AREA 3, PHASE 1, JOB 2.

WHEREAS, Chapter VI, Article 1, Division 5 of the San Diego Municipal Code establishes a procedure for the creation of underground utility districts and requires as an initial step in such procedure the holding of a public hearing to determine whether the public health, safety, or general welfare requires removal of poles, overhead wires, and associated structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service in any such district; and

WHEREAS, it has been recommended that the following underground utility districts be formed:

25TH STREET (FROM MARKET STREET TO COMMERCIAL STREET) UNDERGROUND UTILITY DISTRICT, as more particularly shown on Drawing No. 30655-D, on file in the office of the Clerk as Document No. RR- 293977-1;

B STREET (FROM 19TH STREET TO 30TH STREET) UNDERGROUND UTILITY DISTRICT, as more particularly shown on Drawing No. 30644-1-D, on file in the office of the City Clerk as Document No. RR- 293977-2;

CCDC AREA 3, PHASE 1, JOB 2 UNDERGROUND UTILITY DISTRICT, as more particularly shown on Drawing No. 30581-D, on file in the office of the City Clerk as Document No. RR- 293977-3 ;

SATURN BOULEVARD (FROM CORONADO AVENUE TO LEON AVENUE) UNDERGROUND UTILITY DISTRICT, as more particularly shown in Drawing No. D-30652, on file in the office of the City Clerk as Document No. RR- 293977-4 ;

SCOTT STREET (900 BLOCK) UNDERGROUND UTILITY DISTRICT, as more particularly shown on Drawing No. D-30650, on file in the office of the City Clerk as Document No. RR- 293977-5 ;

SILVERADO STREET (EADS AVENUE TO IVANHOE AVENUE) UNDERGROUND UTILITY DISTRICT, as more particularly shown on Drawing No. D-30647, on file in the office of the Clerk as Document No. RR- 293977-6 ;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. Notice is hereby given that a public hearing will be held by the Council of The City of San Diego on November 21, 2000, at the hour of 10:30 a.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, to determine whether the public health, safety, or general welfare requires the removal of poles, overhead wires, and associated overhead structures and the underground installation of wires and facilities for supplying electric, communication, community antenna television or similar or associated service in the Districts described above.

2. At such hearing, all persons interested shall be given an opportunity to be heard and the hearing may be continued from time to time as may be determined by the City Council. The decision of the City Council as to the formation of the District as described above shall be final and conclusive.

3. The City Manager shall notify all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code and each utility company concerned of the time and place of the hearing by following the procedure set forth in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.
