 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Lowell Street, as more particularly shown on Drawing No. 19117-B, and described in the legal description marked as Exhibit "A1," on file in the office of the City Clerk as Document No. RR-293986 / which is by this reference incorporated herein and made

a part hereof, is ordered vacated; excepting that the area shown on Drawing No. 19117-B, as described in legal description marked as Exhibit "A3," on file in the office of the City Clerk as Document No. RR-293986, which is by this reference incorporated herein and made a part hereof, designated as a general utilities and access easement, is reserved as a general utilities easement for the construction and maintenance of public utilities and appurtenances thereto with the right of ingress and egress for such purposes.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
