WHEREAS, on December 14, 1999, the City Council authorized the City Manager to execute a phase funded agreement with SVERDRUP Civil, Inc. for Design/Construction Management services for the Ballpark Infrastructure Project and to expend \$6,390,000 for Phase 1 of the contract; and

WHEREAS, on June 27, 2000, the City Council authorized the expenditure of an additional \$3,800,000 for SVERDRUP Civil, Inc. for Phase 2 of the contract, for continued design and construction services; and

WHEREAS, the approval of this action would authorize the advance of \$700,000, from a funding source identified by the City Manager, to provide additional interim funding for SVERDRUP Civil, Inc. for Phase 3 of the contract, to continue design and construction services for City-related expenses associated with the Ballpark Infrastructure Project; NOW, THEREFORE.

BE IT RESOLVED, by the Council of the City of San Diego, that the expenditure of the sum of \$700,000, for the purpose of additional interim funding for SVERDRUP Civil, Inc. for continued design and construction services for City-related expenses associated with the East Village Redevelopment and Ballpark Infrastructure Project, is hereby authorized.

BE IT FURTHER RESOLVED, that the reallocation of \$700,000 from CIP 36-063.0, Central Police Garage Relocation, to the East Village Redevelopment and Ballpark Infrastructure Project for continued design and construction services, be and it is hereby

authorized.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to reallocate \$700,000 of funding to CIP 36-063.0, Central Police Garage Relocation, from Ballpark Project permanent financing upon receipt, and upon certification of fund availability by the City Auditor.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to make any budgetary adjustments necessary to implement this action.
