BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San

Diego, the easement over, under, upon and across portions of Lots 1 through 71 inclusive,

designated as "General Utility and Access Easement Granted Hereon," as granted and shown on

the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San

Diego, the easement over, under, upon and across all of Lot "B" designated as "Open Space

Easement Granted Hereon," as granted and shown on the MAP and subject to the conditions set

forth on the MAP.

BE IT FURTHER RESOLVED, that the Clerk of the City is authorized and directed to

endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP

and that the streets and portions of streets are accepted on behalf of the public as stated in this

resolution.

BE IT FURTHER RESOLVED, that the City Clerk is directed to transmit the MAP to the

Clerk of the Board of Supervisors of the County of San Diego, California, for recordation.
