



LEGAL DESCRIPTION

STREET RIGHT-OF-WAY

HARVEST RUN DRIVE

BEING A PORTION OF THE WEST HALF OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER, IN SECTION 29, TOWNSHIP 14 SOUTH, RANGE 3 WEST, SAN BERNARDINO MERIDIAN, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO THE UNITED STATES GOVERNMENT SURVEY APPROVED MAY 20, 1884, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

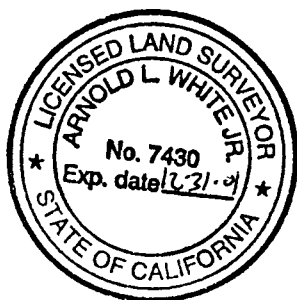
COMMENCING AT THE EAST QUARTER CORNER OF SAID SECTION 29; THENCE, ALONG THE NORTH LINE OF THE SOUTHEAST QUARTER OF SAID SECTION 29

1. NORTH 88°21'08" WEST 329.76 FEET TO THE NORTHEAST CORNER OF THE WEST HALF OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 29; THENCE ALONG THE EAST LINE OF SAID WEST HALF
2. SOUTH 01°14'58" WEST 623.80 FEET TO THE POINT OF BEGINNING; THENCE
3. NORTH 85°11'05" WEST 133.44 FEET TO THE BEGINNING OF A NON-TANGENT 458.00 FOOT RADIUS CURVE CONCAVE TO THE NORTH, A RADIAL LINE TO SAID BEGINNING BEARS SOUTH 04°48'55" WEST; THENCE ALONG THE ARC OF SAID CURVE
4. WESTERLY AND NORTH-WESTERLY 206.52 FEET THROUGH A CENTRAL ANGLE OF 25°50'09" TO THE WEST LINE OF SAID WEST HALF; THENCE ALONG SAID LINE
5. SOUTH 01°13'38" WEST 82.59 FEET TO THE BEGINNING OF A NON-TANGENT 458.00 FOOT RADIUS CURVE CONCAVE TO THE NORTH, A RADIAL LINE TO SAID BEGINNING BEARS SOUTH 21°31'52" WEST; THENCE ALONG THE ARC OF SAID CURVE
6. SOUTHEASTERLY AND EASTERLY 62.64 FEET THROUGH A CENTRAL ANGLE OF 07°50'12" TO THE SOUTH LINE OF SAID WEST HALF; THENCE ALONG SAID SOUTH LINE

7. SOUTH 88°33'47" EAST 269.45 FEET TO THE EAST LINE OF SAID WEST  
HALF; THENCE ALONG SAID EAST LINE

8. NORTH 01°14'37" EAST 34.70 FEET TO THE POINT OF BEGINNING.
