WHEREAS, the City of San Diego and Market Street Square, a California limited partnership, have negotiated a First Amendment to Lease for the continued lease of space for a police storefront located at 205 "G" Street, at the initial rental rate of \$1,705.50 per month. The occupancy of the space will be for a term of three (3) years, effective from September 1, 2000, and terminating August 31, 2003, with one 2-year option to extend the lease; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager is authorized to execute, for and on behalf of the City of San Diego, the First Amendment to Lease, at an initial rent of \$1,705.50 per month, under the terms and conditions set forth in that First Amendment to Lease on file in the office of the City Clerk as Document No. RR-294119.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that an expenditure of \$17,055.00 from the Police Department's Fund 100, for FY 2001, is authorized.
