WHEREAS, Robert Grinchuk is an active owner and manager of residential property in San Diego as a principal in Bobolink Property Management for the past 16 years; and

WHEREAS, Robert Grinchuk is a nationally recognized consultant to the rental housing industry and has co-authored textbooks and courses that are used in California for certification of resident apartment managers through the California Apartment Association and the Apartment Association–Southern California Cities; and

WHEREAS, Robert Grinchuk is also strongly committed to community service, and has served as chair of Uptown-Planners, past president of the Hillcrest Business Association, founder and past president of the Greater Golden Hill Community Development Corporation, past vice president of the Business Improvement District's executive council, and on the executive committee of Save Our Heritage Organization (SOHO). He currently serves as the president of the Uptown Parking District, on the executive committee of the Hillcrest Business Association, and is a member of the board of directors of Mercy Gardens, which provides housing for people living with HIV/AIDS; and

WHEREAS, Robert Grinchuk is the immediate past president of the board of directors of the San Diego County Apartment Association, and is a member of the board of the California Apartment Association and its vice president for Southern California; and

WHEREAS, Robert Grinchuk earned a Ph.D. in American Studies at the University of Minnesota, and holds a master's degree in American Studies from New York University and a

bachelor of arts degree in journalism from Lehigh University; and

WHEREAS, Robert Grinchuk is a graduate of LEAD San Diego's class of 1997, was appointed by Mayor Susan Golding to the San Diego Housing Commission in 1998, and was awarded a District Three Community Spirit Award with his partner Reuel Olin in 1997; and

WHEREAS, at a gala celebration on November 30, 2000, Robert Grinchuk will be awarded the 2000 Mark of Excellence Industry Achievement Award by the board of directors of the San Diego County Apartment Association for his lifetime commitment to the rental industry which has had a lasting, positive effect on rental housing businesses and their customers; NOW, THEREFORE,
