RESOLUTION ADOPTING THE REVISED
CONFLICT OF INTEREST CODE FOR THE
CITY LAND USE BOARDS AND COMMISSIONS

WHEREAS, by Resolution No. R-288131, adopted on December 2, 1996, the City Council approved the Conflict of Interest Code for the City's Land Use Boards and Commissions, which was revised and updated following the required City-wide biennial review of all conflict of interest codes for which the City Council serves as code reviewing body; and

WHEREAS, San Diego Municipal Code section 26.0106 requires City boards and commissions that deal with land use issues to have conflict of interest codes due to the unique and serious potential conflicts of interest that arise with land use issues; and

WHEREAS, Government Code section 87306.5 requires biennial review of local agency conflict of interest codes every even-numbered year; and

WHEREAS, Government Code section 87306 requires agencies to amend their conflict of interest codes whenever an amendment is necessitated by changed circumstances, including the creation of new positions which must be designated and relevant changes in the duties assigned to existing positions; and

WHEREAS, the City Attorney has proposed changes to Appendix A of the City Land Use Boards and Commissions conflict of interest code to accurately reflect the boards currently included in the code, and to allow for new land use boards which are developed to be covered by


the code; NOW, THEREFORE,

BE IT RESOLVED that the proposed changes to Appendix A of the conflict of interest code for City Land Use Boards and Commissions are hereby approved and are incorporated into that conflict of interest code.

BE IT FURTHER RESOLVED that revised Appendix A to the Conflict of Interest Code for City Land Use Boards and Commissions be placed on file in the Office of the City Clerk as Document No. RR-294179.

BE IT FURTHER RESOLVED that the revised Conflict of Interest Code for the City Land Use Boards and Commissions becomes effective upon the date of adoption of this resolution.

APPENDIX B

DISCLOSURE CATEGORY

Category 1 (required by San Diego Municipal Code Section 26.0106)

Investments, business positions, and sources of income of the type which engage in land development, construction, or the acquisition or sale of real property; or

Interests in real property located within the City, including real property located within a two-mile radius of any property owned or leased by the City. An interest in real property that is used as a personal residence is not required to be disclosed, unless the residence is also used for business purposes.
