BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is authorized to add the following projects to the FY2001 Capital Improvements Program Budget: CIP No. 29-416.0, Penasquitos Creek Neighborhood Park - Tot Lot Upgrade; CIP No. 29-417.0, Ridgewood and Adobe Bluffs Neighborhood Parks - Shade Structures; and CIP No. 29-423.0, Canyonside Community Park - Upgraded Sports Field Lighting.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$319,000 from Black Mountain Ranch Development Agreement, Fund No. 392190, for park improvements as follows: \$150,000 for CIP No. 29-416.0, Penasquitos Creek Neighborhood Park - Tot Lot Upgrade; \$80,000 for CIP
