
RESOLUTION NUMBER R- 294263

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes acceptance of repayment of \$27,445 in Community Development Block Grant funds previously loaned to the Redevelopment Agency of the City of San Diego [the Agency] from the Mount Hope Redevelopment Project, and authorizes the reloan and transfer of the same CBDG funds as an interest bearing loan of \$27,445 to the Agency to be used solely and exclusively for the purpose of providing funds for use in the Central Imperial Redevelopment Project, and to be repaid as soon as practicable from tax increment or other appropriate and available revenue.
