APPROVING MAP OF DEL MAR MESA  
ESTATES UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds that certain map surveyed by Richard Eugene Gaddy, Licensed Land Surveyor, titled "Del Mar Mesa Estates Unit No. 2" (the "MAP"), being a subdivision of the south half of the northeast quarter and a portion of the northwest quarter of the southeast quarter of Section 20, all being in Township 14 South, Range 3 West, San Bernardino Base and Meridian, in the City of San Diego, County of San Diego, State of California, according to Official Plat thereof, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that the MAP is in substantial conformance with the approved tentative map; that the MAP and the subdivision of land shown thereon is approved and accepted; and the Council accepts on behalf of the public, the following: Del Mar Mesa Road, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities, designated as "Drainage Easement Granted Hereon," as granted and shown on the MAP and subject to the conditions set forth on the MAP.


BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San Diego, that easement for the construction and maintenance of landscaping, irrigation systems, erosion control facilities, hiking trails, equestrian trails, bikeways, and other similar facilities and appurtenances together with the right of ingress and egress to the general public over, under, upon and across Lots 11 and 13-18 designated as "Recreation Easement Granted Hereon," as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Council accepts on behalf of the City of San Diego, the easement over, upon or across all those portions of Lots 9-18, designated as "Open Space Easement Granted Hereon," as granted and shown on the MAP and subject to the conditions set forth on the MAP.

BE IT FURTHER RESOLVED, that the Clerk of the City is authorized and directed to endorse upon the MAP, as and for the act of the Council, that the Council has approved the MAP and that the streets are accepted on behalf of the public as stated in this resolution.

BE IT FURTHER RESOLVED, that the City Clerk is directed to transmit the MAP to the County Recorder of the County of San Diego, California, for recordation.
