A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE DISPOSITION AND DEVELOPMENT AGREEMENT FOR THE MERCADO DEL BARRIO COMMERCIAL PROJECT IN THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA WITH MERCADO ALLIANCE LLC; APPROVING THE SALE AND/OR LEASE OF PROPERTY IN THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA PERTAINING THERETO; AND MAKING CERTAIN FINDINGS WITH RESPECT TO THE DISPOSITION AND DEVELOPMENT AGREEMENT AND THE SALE AND/OR LEASE.

WHEREAS, the Redevelopment Agency of the City of San Diego [the Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Barrio Logan Redevelopment Project [the Project]; and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency has negotiated and proposes to enter into a Disposition and Development Agreement [the Agreement] with the Mercado Alliance Limited Liability Company [the Developer] pursuant to which the Agency will sell and/or ground lease certain property in the Project to the Developer or its assignee for the development and construction of a commercial retail center which will include an anchor grocery store, a mid-size retail establishment, five multi-tenant buildings, and two fast food or convenience development pads, as described in the Agreement and the exhibits thereto [the Development]; and

WHEREAS, pursuant to the California Community Redevelopment Law (California Health and Safety Code sections 33000 et seq.) the Agency and this City Council held a joint public hearing on the proposed sale and/or lease of such real property pursuant to such Agreement having duly published notice of such public hearing and made copies of the proposed Agreement and other reports and documents available for public inspection and comment; and

WHEREAS, the Developer has executed and submitted to the Agency and the City

Council copies of the proposed Agreement in a form desired by the Developer; and

WHEREAS, the City Council has duly considered all terms and conditions of the proposed sale and/or lease of real property and believes that the development of the real property pursuant to the proposed Agreement is in the best interest of the City and the health, safety, morals, and welfare of its residents, and in accord with the public purposes and provisions of applicable State and local law and requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The City Council recognizes that it has received and heard all oral and written objections to the proposed Disposition and Development Agreement, to the proposed sale and/or lease of the real property pursuant to the proposed Agreement, and to other matters pertaining to this transaction, and that all such oral and written objections are overruled.
- 2. The City Council finds and determines that the consideration to be paid by the Developer for the sale and/or lease of real property in the Project as described in the Agreement is not less than the fair reuse value at the use and with the covenants and conditions and development costs authorized by the Agreement. The City Council further finds and determines

that all consideration to be paid under the Agreement is in amounts necessary to effectuate the purposes of the Redevelopment Plan for the Project.

- 3. The City Council finds and determines that the sale and/or lease of real property in the Project will assist in the elimination of blight in the Project Area, and is consistent with the Redevelopment Plan.
- 4. The sale and/or lease of the real property and the Agreement which establishes the terms and conditions for the sale and/or lease and development of the real property are approved.
- 5. That the Council authorizes the City Clerk to deliver a copy of this resolution to the Executive Director and members of the Agency. A copy of the Agreement, when executed by the Agency, shall be placed on file in the office of the City Clerk as Document No. RR-294285.
