A RESOLUTION DECLARING THE RESULTS OF THE  
MUNICIPAL GENERAL ELECTION AND THE SPECIAL  
MUNICIPAL ELECTION HELD IN THE CITY OF SAN DIEGO  
ON NOVEMBER 7, 2000.

WHEREAS, a municipal general election was held in the City of San Diego on Tuesday, November 7, 2000, pursuant to the provisions of Ordinance No. O-18825 (New Series), for the purpose of electing candidates to the offices of Mayor and Councilmembers in Districts 1, 3, 5 and 7; and

WHEREAS, a special municipal election was held in the City of San Diego on the same date, pursuant to the provisions of Ordinance No. O-18833 (New Series) adopted on July 31, 2000, in which the special election was consolidated with the state general election for the purpose of submitting to the qualified voters of the City of San Diego one or more ballot propositions; and

WHEREAS, one ballot proposition, Proposition C, was submitted pursuant to Ordinance No. O-18836 (New Series) adopted on August 7, 2000, relating to a measure amending Ordinance No. O-10960 (New Series) adopted on November 7, 1972, as amended by vote of the People on November 8, 1988, as amended by a vote of the People on November 3, 1998, pertaining to the height of buildings in the Coastal Zone; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the municipal general election and the special municipal election, as

certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of these elections has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 427,683.

II

The total vote received by each candidate at the municipal general election is as follows:
