BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with Dudek & Associates, Inc., to provide additional design services for the Bonita Pipeline Phase II project, under the terms and conditions set forth in the amendment to agreement on file in the office of the City Clerk as Document No. RR- 294329.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend an amount not to exceed \$91,420 from Water Revenue Fund 41500, CIP No. 70-920.0, Bonita Pipeline Phase II, for the purpose of funding the above-mentioned amendment to agreement, provided that the City Auditor first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury; and

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
