 - (b) the public will benefit from the vacation through improved utilization of land; and
- (c) the vacation is not inconsistent with the General Plan or an approved Community Plan; and
- (d) the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the street reservation located in Lot "A" of Map 4217, excepting therefrom a general utility and access easement in the north 4 feet and in the south 5 feet, as more particularly described in the legal description marked as Exhibit "A," and as shown on Drawing No. 19265-B marked as Exhibit "B," on file in the office of the City Clerk as Document No. RR-______, which are by this reference incorporated herein and made a part hereof, is ordered vacated.
- 2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
