ORDINANCE NUMBER O- 18939 (NEW SERIES) ADOPTED ON MAY 0 7 2001

AN ORDINANCE OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL RUN-OFF ELECTION TO BE HELD IN COUNCIL DISTRICT 6 FOR THE PURPOSE OF FILLING A VACANCY IN THE OFFICE OF COUNCIL DISTRICT 6 IN THE CITY OF SAN DIEGO ON JUNE 5, 2001.

WHEREAS, Councilmember Valerie Stallings submitted to the City Clerk her resignation from the City Council effective 11:22 a.m. on January 29, 2001; and

WHEREAS, the Charter of the City of San Diego requires that a Special Election to fill a vacant Council office be held within ninety days of the date of vacancy, if there is no regular municipal or statewide election scheduled to be held within 180 days of the vacancy; and

WHEREAS, the City Council called and held a Special Election for that purpose on April 17, 2001; and

WHEREAS, if no candidate receives a majority of votes cast in the special election, Charter section 12 requires that a special run-off election be held within forty-nine days of the first special election, if there is no regular municipal or statewide election scheduled to be held within ninety days of the proposed special run-off election date; and

WHEREAS, no candidate received a majority of votes cast in the first special election held on the 17th day of April, 2001; and

WHEREAS, the City Council intends to fulfill Charter section 12 requirements by calling and holding a special run-off election to determine who shall be elected to serve as Councilmember for Council District 6. NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. It is hereby ordered that a special run-off election be held in Council District Six on Tuesday, June 5, 2001, for the purpose of filling a vacancy in the office of Councilmember for District 6, which vacancy is created by the resignation of the incumbent Councilmember.

Section 2. Under Charter section 12, since no candidate received a majority of votes cast in the special election held on April 17th, the two candidates receiving the highest number of votes cast for the vacant seat in that special election shall be the only candidates on the June 5th ballot for the vacant Council seat and the names of only those two candidates shall be printed on the ballot for that seat.

Section 3. The person elected at the special election or at the special run-off election shall serve for the remainder of the unexpired term, that is, until December 2, 2002.

Section 4. For the purpose of the special run-off election on June 5, 2001, the election precincts shall be the precincts established by the Board of Supervisors of the County of San Diego; provided, however, that certain precincts shall be consolidated in the manner indicated on the list of consolidated precincts on file in the Office of the City Clerk.

Section 5. The City Clerk shall designate the polling places, and shall appoint the members of the precinct boards for the special election.

Section 6. The polls for the special election shall be open from 7:00 a.m. until 8:00 p.m. on Tuesday, June 5, 2001.

Section 7. The City Clerk is hereby directed to procure and supply the required number of ballots, sample ballots, equipment supplies and other printed matter.

Section 8. The following rates of compensation are hereby established for the special run-off election.

Section 9. The City Clerk is hereby directed to cause this ordinance to be published once in the official newspaper of The City of San Diego.

Section 10. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 11. Pursuant to section 17 of the Charter of The City of San Diego, this ordinance shall take effect on the date of its adoption.
