# ADOPTED ON JUN 5 2001

### AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE A FOURTH AMENDMENT TO OFFICE LEASE AGREEMENT WITH 400 WEST BROADWAY, LLC FOR OFFICE SPACE AND CHILD-CARE FACILITY SPACE

WHEREAS, the City's office space needs in the Comerica Bank Building, 600 B Street, has expanded beyond current capacity; and

WHEREAS, during the June 22, 2000, budget deliberations, the City Manager was directed to pursue options for leasing space for a downtown child-care facility for City employees that would be in close proximity to the City Administration Building; and

WHEREAS, the City and 400 West Broadway, LLC, a California limited liability company, have negotiated a Fourth Amendment to Office Lease for space at the Comerica Bank Building; said space to be used as general office space and as a City child-care facility. The total area being leased will be approximately 157,314 square feet. The existing leased space, approximately 114,594 square feet, will be leased at a monthly rental rate of \$1.45 per square foot or \$166,161.30 per month, and the expansion space, approximately 42,720 square feet, will be leased at \$1.60 per square foot or \$68,353.00 per month. The term of the amendment would be for approximately 10 years, with a lease termination date of May 31, 2013; NOW, THEREFORE, BE IT ORDAENED, by the Council of the City of San Diego, as follows:

Section 1. That the City Manager is authorized to execute, for and on behalf of the City of San Diego, a Fourth Amendment to Office Lease with 400 West Broadway, LLC., for the lease of approximately 157,314 square feet, for a total monthly rental rate of \$234,513.30, for a term of approximately 10 years, under the terms and conditions set forth in that Fourth Amendment to Office Lease agreement on file in the office of the City Clerk as

Section 2. That the City Auditor and Comptroller is authorized to expend an amount not to exceed \$5,600.00 from Development Services Fund No. 41300, Department 1300, for rent from the FY 2001 budget.

Section 3. That the City Auditor and Comptroller is authorized to expend an amount not to exceed \$271,150.00 for space costs and data infrastructure costs from General Fund No. 100, Department 601, for rent from the FY 2001 budget.

Section 4. That a full reading of this Ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.
