ORDINANCE NUMBER O- 18990 (NEW SERIES)

ADOPTED ON SEP 24 2001

AN ORDINANCE SETTING ASIDE AND DEDICATING CITY-OWNED LAND, KNOWN AS "STARKEY MINI-PARK" IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK.

WHEREAS, San Diego Charter section 55 provides that all real property owned in fee by the City that is dedicated by ordinance for park and recreation purposes shall not be used for any but park and recreation purposes without a changed use or purpose being authorized by a two-thirds vote of the people; and

WHEREAS, in accordance with Charter section 55 and Council Policy 700-17, the Park and Recreation Board has reviewed the City's inventory of park lands to determine which parks have met the requirements for dedication by ordinance; and

WHEREAS, the Park and Recreation Board has identified five parks that meet the Charter and Policy requirements, one of which is known as "Starkey Mini-Park," and recommends that those parks be dedicated by ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That various parcels of City-owned land known as "Starkey Mini-Park," which is more particularly described in Exhibit A, attached hereto and incorporated herein by this reference, is set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the City Council of the City of San Diego hereby specifically reserves the right to establish underground public service easements through and across the dedicated


property so long as the construction and maintenance of the subject easements do not substantially negatively impact the availability of the property for use for park and recreational purposes.

Section 3. That the City Clerk is authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 4. That a full reading of this ordinance is dispensed with prior to its final passage, a written or printed copy having been available to the City Council and the public a day prior to its final passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.

PARCEL 5
(Starkey Mini-Park)

ALL THAT PORTION OF BLOCK "G" OF STARKEY'S PROSPECT PARK , IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO MAP THEREOF NO. 1729, FILED IN THE OFFICE OF THE SAN DIEGO COUNTY RECORDER, MAY 6, 1922, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 9, BLOCK 'F', SAID STARKEY'S PROSPECT PARK; THENCE SOUTHEASTERLY ALONG THE SOUTHEASTERLY PROLONGATION OF THE WESTERLY LINE OF SAID LOT 9, BEING ALSO THE WESTERLY LINE OF BLOCK "G", A DISTANCE OF 50 FEET TO THE TRUE POINT OF BEGINNING; ALSO BEING THE SOUTHWEST CORNER OF THAT PROPERTY DEDICATED FOR PARK PURPOSES BY ORDINANCE NUMBER O-15953, DATED APRIL 25, 1983, THENCE CONTINUING SOUTHEASTERLY ALONG THE WESTERLY PROLONGATION OF LOT 9 AND BLOCK "G" A DISTANCE OF 87.16 FEET TO THE POINT OF INTERSECTION WITH THE SOUTHERLY PROLONGATION OF THE EASTERLY LINE OF LOT 9 , THENCE NORTHERLY ALONG SAID SOUTHERLY PROLONGATION OF THE EASTERLY LINE OF LOT 9 A DISTANCE OF 104.81 FEET TO A POINT BEING THE SOUTHEASTERLY CORNER OF THAT PARK PROPERTY DEDICATED FOR PARK PURPOSES BY ORDINANCE NUMBER O-15953, DATED APRIL 25, 1983, THENCE SOUTHWESTERLY ALONG SAID DEDICATED PROPERTY LINE A DISTANCE OF 101.67 FEET TO THE TRUE POINT OF BEGINNING.
