RESOLUTION NUMBER R- 294484 ADOPTED ON JAN 3 0 2001

WHEREAS, members of the community have requested that a small, prefabricated modular comfort station be placed at the Scripps Ranch Neighborhood Park III [Park], and that the comfort station be maintained by Miramar Ranch North Maintenance Assessment District [District] fees; and

WHEREAS, because the Park is too small to meet the City's standards for the City to fund the installation and maintenance of such a comfort station, installation of the comfort station will be funded by the Village and Country Settlement Fund [Settlement Fund], which must be used to finance projects within the community of Scripps Ranch, which includes Scripps Miramar Ranch and Miramar Ranch North; and

WHEREAS, in order for the District to maintain the comfort station, a ballot protest procedure must be conducted to permit property owners in the District to determine whether they support funding such maintenance through the District; and

WHEREAS, if the ballot protest procedure is not completed by time that the comfort station has been installed, maintenance of the comfort station could be funded on an interim basis by the Settlement Fund; and

WHEREAS, if as a result of the ballot protest procedure, the property owners do not support the maintenance of the comfort station, it could be removed from the Park; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is authorized to add CIP No. 29-421.0, Scripps Ranch Neighborhood Park III - Comfort Station, to the FY 2001 Capital Improvements Program Budget.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to appropriate and expend an amount not to exceed \$90,000 from the Village and Country Settlement Fund, Fund No. 10604, for use on CIP No. 29-421.0, Scripps Ranch Neighborhood Park III - Comfort Station.

BE IT FURTHER RESOLVED, that if the property owners in the District, through a ballot protest procedure, do not support the maintenance of the comfort station, the City Manager shall ensure that the comfort station is removed from the Park.
