WHEREAS, the Save Outdoor Sculpture! [SOS!] Heritage Preservation grant program has made grant funds available to restore and preserve outdoor sculptures [Grant]; and

WHEREAS, currently the *El Charro* equestrian bronze sculpture [Project] in Presidio

Park is in very poor condition; and

WHEREAS, the City desires to restore the *El Charro* sculpture to its original condition when it was presented as a gift to the United States from the president and people of Mexico in 1970 to commemorate the City's 200th anniversary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Manager or his duly designated representative is authorized to apply to the SOS! for the Grant for the Project.
- 2. That the City Manager or his duly designated representative is authorized to take all necessary actions to secure and accept the Grant for the Project.
- 3. That the City Manager or his duly designated representative is authorized to take all necessary actions to complete the Project, including conducting negotiations and executing and submitting applications, agreements, amendments and payment requests.
- 4. That the City Auditor and Comptroller is authorized to expend an amount not to exceed \$10,000 from Commission for Arts and Culture Arts Fund (Fund 10271), and \$28,200

from Park and Recreation Department matching funds account (Fund 10365), to "Presidio Park - El Charro Sculpture" project, contingent upon receipt of a fully executed grant agreement.
