A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF NOVEMBER 14-16, 2000, FOR THE PROJECT AREA COMMITTEE FOR THE CENTRE CITY REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of the City of San Diego [the Council] by Resolution

No. R-276511, adopted the Procedure of the Formation of a Project Area Committee [the

Procedure] for the Centre City Redevelopment Project Area Project Area Committee [PAC] at its

September 11, 1990, meeting, and

WHEREAS, the Procedure has been amended by Resolution No. R-287012 adopted on March 5, 1996 and by Resolution No. R-287208 adopted on April 16, 1996, and

WHEREAS, on November 20, 1990 the Council by Resolution No. R- 276892 approved the PAC representatives initially elected to the PAC; and

WHEREAS, since the initial election of PAC members, vacancies have occurred on the PAC, and

WHEREAS, after notice was given in accordance with the Procedure, as amended, an election of the PAC was conducted on November 14-16, 2000; and

WHEREAS, a challenge to the election has been filed by Henry N. Addington and Judith Jeannotte; and

WHEREAS, this Council, having heard and considered the facts presented by Mr. Addington, Ms. Jeannotte, and Centre City Development Corporation [CCDC] staff, is satisfied that the election was held according to the Procedure, as amended; and

WHEREAS, a representative from the City Clerk's Office attended the election to ensure its validity, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Council finds that the challenge to the election is rejected and that all procedures adopted by Resolution Nos. R-276511, R-287012, and R-287208 were followed in the election.
- 2. That Betty Ens was elected as the Residential Tenant representative on the Marina ballot for the Centre City Redevelopment Project Area Committee, as noted by the City Clerk's verification of the election results of the November 14-16, 2000 election, which is attached and incorporated by this reference.
- 3. That the Council concurs that the election results of November 14-16, 2000, are valid and binding in accordance with the Procedure, as amended.
