WHEREAS, on March 27, 2001, the Council of the City of San Diego considered two actions. The first action was consideration of a Third Amendment to the Consultant Agreement for Sorrento Valley Road Improvement Project [R-2001-783] for approval. The second action was certification of the Environmental Impact Report [EIR] Report LDF 99-0220 [R-2001-795]

WHEREAS, after consideration of these two actions, the City Council did not approve Resolution No. R-2001-783 and Resolution No. R-2001-795.

BE IT RESOLVED, by the City Council that the City Manager is directed to return to City Council with an action to amend the applicable Torrey Pines Community Plan and Local Coastal Program Land Use Plan. The amendment shall propose a deletion of Sorrento Valley Road between Carmel Valley Road and Carmel Mountain Road as part of the traffic circulation system. This action shall include all necessary documents and/or reports with all necessary findings, including, but not limited to, all supporting environmental documents and a street vacation, if legally necessary.

BE IT FURTHER RESOLVED, by the City Council that the City Manager is directed to return with information regarding the future redevelopment of Sorrento Valley Road between Carmel Valley Road and Carmel Mountain Road for its consideration. The Manager shall include reports on two options described below and recommend all necessary actions.

Option 1. Redevelop and design the street known as Sorrento Valley Road between Carmel Valley Road and Carmel Mountain Road primarily as a recreational amenity for pedestrians and bicycles, with understanding that limited vehicular access is necessary for emergencies, maintenance of City and SDG&E facilities, and access to property, as is deemed necessary under the law.

Option 2. Redevelop and design the street known as Sorrento Valley Road between Carmel Valley Road and Carmel Mountain Road for limited one-way vehicular access open to the public during daylight hours, subject to intermittent closure at the direction of the State of California representatives, in combination with a two-way pedestrian and bicycle pathway similar to one currently located on the Father Junipero Serra Trail in Mission Trails Regional Park.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the City Manager is directed to provide a report on four pending projects in the area of Sorrento Valley Road that directly affect the subject transportation circulation. The four projects are Vista Sorrento Parkway; Mira Sorrento Parkway, Carroll Canyon Road extension; and The Project Study Report for the I-5 exit overpass traversing over the railroad tracks at Roselle Street, which report this Council wishes to expedite.

BE IT FURTHER RESOLVED, by the City Council that the City Manager is directed to work with State Parks and community groups to develop a vision, and to compose a Master Plan for the Torrey Pines State Reserve, including, but not limited to, the accommodation of the park's habitat management. The City Manager is further directed to work with the State of California to obtain funding to implement this Master Plan and to report to Council on the

development of the Master Plan within a reasonable amount of time. The report on the Master Plan does not need to coincide with the Council presentation on the redevelopment of Sorrento Valley Road.
