WHEREAS, the California Department of Justice maintains an automated system known as the California Identification System (Cal-ID) for storing, tracing and identifying latent and ten-print fingerprints, which are accessible to authorized law enforcement agency personnel via Remote Access Network (RAN), and

WHEREAS, the San Diego Sheriff's Department is the San Diego County proprietary agency for the local Cal-ID/RAN system; and

WHEREAS, in 1987, the City of San Diego entered into an agreement with the County of San Diego and the State of California to participate in Cal-ID/RAN Resolution R-269704, dated November 9, 1987, and

WHEREAS, the last agreement for the continuation of the program was dated November 20, 1995, Resolution RR-286586; and

WHEREAS, the San Diego Police Department desires to continue participation in Cal-ID/RAN; and

WHEREAS, all costs associated with the Cal-ID Program are annually distributed by a formula and recalculated on a yearly basis, over the course of the five-year agreement, using the City's updated population and crime index figures to determine the City's share of costs each year; and

WHEREAS, the cost of the Cal-ID Technicians, communication line cost and the training costs will also be updated each year and deducted as direct costs, incurred by the City, to operate

the program; and

WHEREAS, the net cost to the City for the fiscal year 2001 at years end will be approximately \$205, 628; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and is hereby, authorized and empowered to enter into and execute, for and on behalf of the City, an agreement with the County of San Diego to participate in the Cal-ID/RAN system for a term of five years from July 1, 2000, through June 30, 2005, and to provide all appropriate costs for said system subject to annual appropriation of funds by the San Diego City Council.
