- 3. That the expenditure of \$2.5 million in CIP No. 58-127.0, for the State Route 15 Bikeway, extending along I-15 between Landis Street and Camino Del Rio South, contingent upon receipt of a fully executed program supplement, and receipt of funds from SANDAG, is hereby authorized
- 4. That the City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess funds, if any, to the appropriate reserves
