BE IT RESOLVED, by the Council of the City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$1,689,000 from the Sewer Fund - Unallocated Reserve Fund No 41509, Dept 777, Org 445, Program Element 777210, Object Account 4903, to Fund No 41506, Dept 773, Org 190, Object Account 4972

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,689,000 from Fund No 41506, Dept 773, Org 190, Object Account 4972, Job Order 1906, is hereby authorized, solely and exclusively to provide funds for the penalty imposed in Administrative Civil Liability Order No 2000-103, including the Supplemental Environmental Project required by the Order, wherein the City would join the Southern California Beach Valuation Project, administered by the Santa Monica Bay Restoration Foundation

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is further authorized to issue the following checks one check in the amount of \$1,426,500 made payable to the San Diego Regional Water Quality Control Board as payment of the penalty for Administrative Civil Liability Order No 2000-103, and one check in the amount of \$262,500 made payable to the Santa Monica Bay Restoration Foundation as payment of the Supplemental Environmental Project required in the Order
