A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPLICATION AND EXECUTION OF A CALIFORNIA INTEGRATED WASTE MANAGEMENT BOARD PARK PLAYGROUND ACCESSIBILITY AND RECYCLING GRANT AND AMEND THE FISCAL YEAR 2001 CAPITAL IMPROVEMENTS PROGRAM BUDGET.

WHEREAS, the Playground Safety and Recycling Act authorizes the California Integrated Waste Management Board [CIWMB] to administer a grant program to upgrade public playgrounds using recycled-content materials and to assist them in meeting state and federal accessibility standards relating to public playgrounds; and

WHEREAS, the CIWMB has allocated \$2.558 million for the Park Playground Accessibility and Recycling Grant Program for Fiscal Year 2000-2001, and

WHEREAS, eligible applicants must provide a 50 percent match, which may be reduced to a 25 percent match upon verification that the proposed playground project is located within an Enterprise Zone, as determined by the California Trade and Commerce Agency; and

WHEREAS, the City of San Diego wishes to apply for grant funding through the Park Playground Accessibility and Recycling Grant Program for the City Park and Recreation Department's plans to upgrade the children's playground at Southcrest Community Park; and

WHEREAS, the grant funding would pay for the recycled-content playground surfacing, two entry ramps, and two pieces of play equipment; and

WHEREAS, the CIWMB grant will supplement the \$147,570 received through the State of California FY 2001 budget process to upgrade the Southcrest Community Park playground; and

WHEREAS, if the CIWMB grant is secured, the City will receive \$50,000 for CIP 29-662.0, Southcrest Community Park - Tot Lot Upgrade; and

WHEREAS, Southcrest Community Park is located within the San Diego Metropolitan Enterprise Zone, which makes this grant eligible for the reduced 25 percent matching funds requirement; and

WHEREAS, the City's match of \$12,500 will be transferred from Park and Recreation Grant Match Funding CIP 20-013.0 to the Southcrest Community Park - Tot Lot Upgrade CIP No. 29-662.0; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the City Manager, or designee, is authorized to apply to the California Integrated Waste Management Board for grant funding for the above-mentioned project.
- 2. That the City Manager, or designee, is authorized to take all necessary actions to secure and accept the grant funds from the California Integrated Waste Management Board for the above-mentioned project.
- 3. That the City Manager, or designee, is authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the above-mentioned project.

- 4. That the City Auditor and Comptroller is authorized to appropriate and expend the grant funds, if secured, in accordance with the terms and conditions set forth in the approved grant.
- 5. That the City Auditor and Comptroller is authorized to establish a special interest bearing fund for the grant, if secured.
- 6. That the Fiscal Year 2001 Capital Improvements Program Budget is amended by increasing the project budget for CIP 29-662.0, Southcrest Community Park Tot Lot Upgrade, in the amount of \$50,000, contingent upon receipt of a fully executed grant agreement from CIWMB.
- 7. That the City Auditor and Comptroller is authorized to transfer and expend the currently appropriated \$12,500 from CIP 20-013.0, Park and Recreation Grant Match Funding, Fund 630221, to CIP 29.662.0, Southerest Community Park Tot Lot Upgrade.
