A RESOLUTION DECLARING THE RESULTS OF THE
SPECIAL ELECTION HELD IN COUNCIL DISTRICT SIX ON
TUESDAY, APRIL 17, 2001.

WHEREAS, a special election was held in Council District Six in the City of San Diego on Tuesday, April 17, 2001, pursuant to the provisions of Ordinance No. O-18920 (New Series), adopted January 30, 2001, for the purpose of nominating candidates and, if any candidate received a majority of all votes cast, for the purpose of electing that candidate, and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the special election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of this election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27 0411 of the San Diego Municipal Code, as follows:

The whole number of votes cast in Council District Six was 19,048.


