No. 2601, Dept. No. 532, Job Order No. 002786, to complete the Mira Mesa Senior Center expansion project.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$12,254 from General Fund No. 100, Org. No. 2601, Dept. No. 532, is hereby authorized, solely and exclusively for the purpose of completing the Mira Mesa Senior Center expansion project.
