

RESOLUTION NUMBER R- 294944

ADOPTED ON MAY 29 2001

A RESOLUTION APPROVING THE ISSUANCE OF BONDS BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR THE PARK HAVEN COURT APARTMENTS PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986.

WHEREAS, the Housing Authority of the City of San Diego [the Authority] adopted a resolution that constituted a declaration of official intent to issue not to exceed \$1,800,000 aggregate principal amount of multifamily housing revenue bonds for the Park Haven Court Apartments [the Bonds] to finance the acquisition and rehabilitation of approximately 40 units of multifamily rental housing located at 4010-4050 Park Haven Court, in the City of San Diego, as described in the form of notice of public hearing attached as Exhibit A [the Project], and

WHEREAS, in order for interest on the Bonds to be tax-exempt, Section 147(f) of the Internal Revenue Code of 1986 requires that issuance of the Bonds be approved by the City Council as the applicable elected representative, with respect to the Authority, after a public hearing following reasonable public notice; and

WHEREAS, notice of a public hearing with respect to the proposed issuance of the Bonds was published in a newspaper of general circulation in the City on May 9, 2001; and

WHEREAS, the hearing was held on May 29, 2001, and an opportunity was provided at the hearing for interested persons to express their views on the issuance of the Bonds and on the nature, location and operation of the Project; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that this City Council, as the applicable elected representative with respect to the Authority under Section 147(f) of the Code, approves the issuance of the Bonds by the Authority.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of San Diego on Tuesday, May 29, 2001, at the hour of 10:00 a.m., at the City Council Chambers, 12th floor, 202 C Street, San Diego, California, will hold a public hearing in accordance with Section 147(f) of the Internal Revenue Code of 1986 with respect to the proposed issuance by the Housing Authority of the City of San Diego of its multifamily housing revenue bonds, in order to finance the acquisition and rehabilitation of the multifamily rental housing projects described in the following table:

The owner of the Park Haven Court Apartments (the "Project") will be Bolt Housing Partners L.P., a California limited partnership formed by the Southern California Housing Development Corporation for the purpose of owning the Project. The initial operator of the Project will be the entity that owns the Project.

Notice is further given that at said hearing, all interested parties will have an opportunity to be heard on the question of whether or not such multifamily housing revenue bonds should be issued.
