WHEREAS, the Project was heard by the Council on April 28, 1997; and

WHEREAS, the Council by Resolution No. R-289593, adopted on April 28, 1997, certified Environmental Impact Report No. 91-0737, on file in the Planning and Development Review Department; and

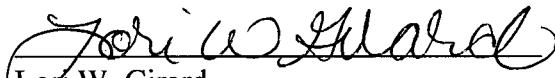

BE IT RESOLVED, by the Council of the City of San Diego, that the information contained in the final document, including any comments received during the public review process, has been reviewed and considered by this Council and it is determined that no substantial changes or new information of substantial importance within the meaning of CEQA Guideline 15162 would warrant any additional environmental review in connection with the approval of the request for additional funding to pay for the final costs associated with the Project.

BE IT FURTHER RESOLVED, and stating for the record, that the final Environmental Impact Report has been reviewed and considered prior to approving the project and that the City Clerk is directed to file a Notice of Determination with the Clerk of the County of San Diego.


