A RESOLUTION DECLARING THE RESULTS OF THE
SPECIAL ELECTION HELD IN COUNCIL DISTRICT
SIX (6) ON TUESDAY, JUNE 5, 2001.

WHEREAS, a special election was held in Council District Six (6) in the City of San Diego on Tuesday, June 5, 2001, pursuant to the provisions of Ordinance No. O-18939 (New Series), adopted May 7, 2001, for the purpose of electing a candidate to the office of Councilmember in District Six (6); and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the Special election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of this election has been completed and the City Clerk has certified the results to the City Council;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in Council District Six (6) was 23,564.

II

The total vote received by each candidate at the Special election is as follows:

DONNA FRYE	12,259
STEVE DANON	11,201

Donna Frye having received a majority of all votes cast is hereby declared elected to the office of Councilmember, District No. 6.

The City Clerk shall make public the results of the canvass of the special election by publication of a copy of this resolution.
